#### 6. CONTINUING BUSINESS

#### A. <u>Update on Vegetation Management Action Plan presentation.</u>

Captain Tyler Sturm presented the update on the Vegetation Management Action Plan and the Vegetation Abatement Program which included identifying properties which required more extensive abatement measures. The District plans to maintain the lots through the Weed Abatement program. He presented a proposed timeline for sending letters and completing work.

Board discussion occurred. President Burke asked if the number of parcels is known and what is the biggest problem in completing the plan. Captain Sturm said 80-100 parcels may be included. The only problem would be funding. Director Sherrill indicated the Board will need actual numbers on the parcels that are to be included. Captain Sturm indicated there will another community meeting and he may be able to create a parcel action map. The District is working with the City of Half Moon Bay to make sure they are not working on sensitive habitats.

#### B. Update on Fire Station 44 Replacement Feasibility Study.

Deputy Chief Jonathan Cox presented the Fire Station 44 Replacement Feasibility Study. The facility will need to be a two-story building and it may be difficult to have the apparatus bay. Option 2 is not an ideal setup, but it is feasible. Option 3 would fit but it would have a tight turning radius. The facility would be behind the apparatus bay. The most logical setup is Option 1 and it would have a drive through apparatus bay. Board discussion occurred. President Burke asked what the timing is for the next step. Deputy Chief Cox indicated this concludes the feasibility portion of the contract. The next step is going to a design and build phase and the District has the design phase budgeted for next year. Director MacKimmie asked where employees would park. Deputy Chief Cox indicated it isn't shown on the study. Director Sherrill asked about sound through the building.

#### K. Fire Chiefs' Report

Deputy Chief Jonathan Cox indicated there are no staffing impacts due to COVID. Self-testing is continuing.

Regarding staffing, two fire apparatus engineer paramedics were offered promotions with the County program. The positions will be filled. Interviews were conducted for the Division Chief of Operations and an offer is expected to be made in the near future.

Regarding information and outreach, the Public Information Officer would be participating in the Disaster Preparedness Day. They will also be sending out a flyer to the District encouraging people to sign up for Community Connect.

Regarding operations, no known calls for service. Chief Armstrong has been working on the State budget which will have a big impact on their department from the State side.

Regarding training, the three drones have been received and training is starting.

No report for prevention.

Regarding facilities, the cameras have been installed at the station. There has been graffiti at the old Station 41. The Sheriff's Office was contacted and it will be painted over once the investigation is complete.

Regarding apparatus, the new Battalion Chief's vehicle is in service and the new Division Chief's vehicle. The final vehicle is being outfitted. The new ERV Polaris is in the bay. The first two of four engines have gone into production.

Chief Armstrong spoke about the State budget and adding in 1,500 positions. One major benefit is the Old Glenwood Camp in La Honda is going to become a hand crew center for Cal Fire.
