# COASTSIDE FIRE PROTECTION DISTRICT SPECIAL BOARD OF DIRECTORS MEETING

#### **December 9, 2020**

#### **LOCATION:**

Pursuant to Governor Newsom's Executive Order N-29-20, the meeting was held by teleconference and Zoom video conference. Members of the public were able to participate via Zoom or by phone. Every vote was done by Roll Call Vote.

#### **ACTION MINUTES**

#### 1. OPEN SESSION

President Burke called to order the special meeting of the Board of Directors of the Coastside Fire Protection District at 6:02 p.m. The special meeting was held on December 9, 2020 due to the regular meeting dates falling close to the Thanksgiving and Christmas holidays.

Carlysle "Sid" Young got confirmation that the Board members did receive her letter. She summarized items in her letter, indicating that the Coastside Inn was sold to the county for homeless people, that today the Planning Commission approved the 48-parking-spot RV park at Capistrano and Highway 1, and the letter said that Café Mezza Luna has locked their back door and the Fire Department may want to look into that. President Burke provided comments.

# 6. CONTINUING BUSINESS

A. <u>Presentation by Division Chief Rich Sampson on CAL Fire San Mateo-Santa Cruz Unit Vegetation Management Efforts</u>

Deputy Chief Jonathan Cox introduced Deputy Chief Rich Sampson, who has been requested to make a presentation on CalFire's vegetation management efforts.

Deputy Chief Rich Sampson gave a lengthy PowerPoint presentation on the fire danger on the San Mateo County Coastside. He discussed each slide, which contained maps of fire locations, number of wildfires and deaths, what changed to make more fires, history of old fires, various types of trees on the Coastside, methods used to remove eucalyptus, how to counter something like the CZU fire, evacuation routes, chipper programs, fire prevention defensible space, fuel reduction tools, outreach efforts, vegetation management enforcement, and finally, "This is not going away any time soon."

Following his presentation, Deputy Chief Sampson responded to questions and comments from the Board. President Burke asked him to provide the Board with a list of what the Coastside Fire Protection District could do to impact the things he has been discussing.

Secretary McShane mentioned that some people like eucalyptus trees because butterflies like them. She indicated she would like to meet with Deputy Chief Sampson in January regarding what she can do to help with vegetation management.

Carlyle "Sid" Young commented on the large eucalyptus grove which is a chokehold on Highway 1 going downhill from the tunnel towards Pacifica. She indicated the Coastsiders would not be able to evacuate going north if that grove was on fire.

# B. <u>Presentation by Deputy Chief Jonathan Cox on Roles and Responsibilities</u> of Agencies and Organizations During a Large Disaster

Deputy Chief Cox made a lengthy PowerPoint presentation on who is responsible for what in a state or local disaster and how the agencies all work together. He described many of the agencies and what each one does during a disaster. He discussed the various agreements that CFPD are part of. He also discussed resources available by following the SEMS (Standardized Emergency Management System), as well as organizations to help with preparedness and recovery.

Following his presentation, Deputy Chief Cox responded to questions and comments from the Board.

## I. Fire Chief's Report

Deputy Chief Jonathan Cox indicated they are continuing to take Covid precautions, and the grant equipment for Personal Protection Equipment is coming in.

He discussed the office upgrades and finalizing the conference room at Station 40.

He reported that he made a presentation for Mid Coast Council regarding disasters and evacuations.

He indicated we have once again received the District of Distinction Award.

As to personnel and staffing, Deputy Chief Cox reported that Chief Larkin conducted interviews for the Division Chief of Operations today, and there should be an announcement in the near future. The front office Staff Analyst position should be posting shortly. And Clinton Dyer, who has been an engineer working at Stations 41 and 44, will be promoted on Monday to the Fire Marshall's office to work with John Rydell.

Deputy Chief Cox indicated there was a cliff rescue last week, and the Sheriff used a drone in this incident.

He reported that the intersection at Highway 1 and Station 40 will be closed during reconfiguration.

He stated they completed a two-week truck academy in November at Station 40.

Staff is working on getting letters out for self-certification due to Covid precautions.

He said he is still waiting for the appraisal for Station 41.

Director MacKimmie asked about drones, and Chief Ian Larkin responded that CalFire has received their Certificate to Operate Drones statewide. Deputy Chief Cox stated that any drone that has parts made in China is not permitted to be purchased.

Director MacKimmie asked if there can be a keypad at the back door of Station 40 for the Directors to be able to get their packets without bothering the firefighters.

President Burke commented on the monthly statistics reports and thanked Cal Fire and Deputy Chief Cox for their great response times.

President Burke thanked everyone who took part in putting together the virtual opening of Station 41.

President Burke asked Deputy Chief Cox to place on the January 2021 agenda to review, discuss, and update the Strategic Plan.
