#### 4. PUBLIC COMMENT

Sid Young spoke about the permit waiver from the County which was extended until July 2023. She asked if there is a reason why the Monterey Cypress or Monterey Pines were not included. Regarding the inspection of businesses, it was a shock to residents about the living conditions on farms. Does the District inspect farms and agriculture type of facilities for safety?

Fire Captain/Fire Marshal Pat Griffin stated they would follow up on the types of trees. A code enforcement program has been created but there are some areas that fall within San Mateo County.

## G. Emergency Preparedness Liaison Report

Dave Cosgrave provided a report on the recent storms and activation of the County EOC. He urged everyone to sign up for SMC Alert again due to the upgraded options in the system. They assisted with the people displaced by the shooting. They are working with FEMA, Cal OES and Small Business Administration for damages from the storms. He is working with the District on the tsunami integration maps. The County is working on cell services and availability in an emergency.

Sid Young spoke about the evacuation seminar. She wondered if there was a Coastside plan being discussed. Dave Cosgrave said the Countywide plan is what they are working on.

## H. <u>CERT Report</u>

Director Sherrill indicated CERT's were busy assisting with the recent storms and the shooting. Coastside CERT donated emergency equipment to residents who were flooded out.

## J. <u>Fire Marshal's Report</u>

Battalion Chief//Fire Marshal Pat Griffin provided statistics for the month and hiring for positions in their office.

## K. Fire Chief's Report

Deputy Chief Jonathan Cox continues to meet with the City Manager. He attended a fire chief's planning retreat to discuss strategic priorities in general.

Regarding personnel, they are hiring some additional apparatus engineers.

Regarding operations, they have been responding to storm events and flooding. They upstaffed six engines and had a representative in the DOC, the City EOC, and the County EOC. They responded to the vehicle over Devil's Slide, a few ocean rescues, and the mass shooting. They will be holding after action lessons learned discussions.

Regarding training, they had a paramedic training and started the volunteer academy.

Regarding facilities, they are painting the top of the generator on Engine 1.

Regarding apparatus, the two new engines are in Sacramento. The dealer is mounting all of the equipment rather than the vendors. Engine 40's engine has been replaced, tests are being run, and then it will be back in service. The self-contained breathing apparatuses have been received and they will roll out with the new engines.
