Director Lees made a correction to the September 24, 2008 minutes. On page 5, the last line of paragraph F, should read as follows: "...second agenda item regarding sharing the Fire Marshal positions."

ON MOTION by Director Cilia, seconded by Director Draper, the Board unanimously approved Item A of the Consent Calendar, as amended. Motion carried 8-0.

NEW BUSINESS (Item A taken out of order to accommodate the speakers)

A. Review and approve the Basic Financial Statements Audit for the period from October 1, 2007 through June 30, 2008

Mr. Ahmed Badawi, a Partner with the firm of Caporicci & Larson, CPAs, made a presentation to the Board regarding the District's responsibilities, the CPA firm's responsibilities, the firm's auditing efforts, and the audit results. Mr. Badawi had previously distributed to the Board the printed presentation, which had been reviewed with him by the Finance Committee.

Mr. Hector Lwin, financial analyst for the District, made positive comments regarding Mr. Badawi's presentation.

Mr. Badawi discussed the District's Basic Financial Statements for the period from October 1, 2007 through June 30, 2008. He and Mr. Lwin responded to questions and comments from the Board.

ON MOTION by Director Lees, seconded by Director McShane, the Board voted unanimously to approve the Coastside Fire Protection District Audit with the amendments discussed at tonight's Board meeting. Motion carried 8-0.

CONTINUING BUSINESS

A. <u>Discuss and approve enrollment in a Post Retirement Health Care Trust Fund</u>

President Burke reported on interviews held with firms to handle the District's Post Retirement Health Care Trust Fund. Board discussion occurred. This item will be brought back to a future meeting.

B. Review progress toward achieving CSDA District of Distinction certification

President Burke requested Board members who have not yet attended the governance training to please arrange to do so.

NEW BUSINESS

B. <u>Discuss and approve recommended staffing changes to Fire Prevention Bureau</u>

Cal Fire Chief John Ferreira discussed proposed staffing changes. He also discussed the Fire Captain and Battalion Chief positions. Board discussion occurred.

ON MOTION by Director Lees, seconded by Director MacKimmie, the Board voted unanimously to give Cal Fire 120-day notice of the elimination of the Inspector and Fire Marshal positions in the next contract. Motion carried 8-0.

Battalion Chief Clayton Jolley discussed contracting and staffing issues between the Coastside Fire Protection District and Cal Fire. Extensive Board discussion occurred.

ON MOTION by President Burke, seconded by Director MacKimmie, the Board voted to direct Cal Fire Chief John Ferreira to arrange to share the Fire Marshal on a trial basis with the San Mateo County Fire Department. Motion carried 7-0-1, with Director Cilia abstaining.

C. <u>Discuss and approve the establishing of a District Facilities Ad-Hoc Committee</u>

President Burke provided background on this issue as this relates to the District's short-term goals, and he discussed the type of people who should be on the committee.

Directors MacKimmie, Cockrell, and Draper volunteered to serve on the committee. President Burke invited the committee to suggest other persons to volunteer on the committee such as realtors, architects, etc. This issue will be brought back on the agenda for the next regular Board meeting.

D. <u>Discuss and approve changing the November 2008 and December 2008 regularly scheduled Board meeting dates</u>

Due to the upcoming holidays, it was suggested to combine the November and December meetings and have one meeting in early December. The date of December 10, 2008 was agreed upon.

ON MOTION by President Burke, seconded by Director Cilia, the Board voted unanimously to hold the combined November and December meetings on December 10, 2008. Motion carried 8-0.
