H. Fire Chief's Report

Regarding the Covid-19 crisis, Deputy Chief Cox reported that the crews remain healthy. The personal protection equipment supply is sufficient at this time, and they have applied for a regional grant for additional PPE that would keep them supplied for another 90 days.

He said there was an incident where someone with flu-like symptoms came into the fire station living area, so they have been operationally revisiting day-to-day operations to avoid that in the future.

He referred to the Statistics Report, indicating that calls are 20% below normal.

He discussed a rescue off of the Ritz Carlton, persons trapped on the rocks after sunset and the tide came in.

He discussed training, which is virtual at this time. They hope to get back to in-person training next month.

He reported on the status of new inspection software, and they have seen an uptake in plan reviews.

He reported that there will be a walk-through punch list next week with Jeff Katz at the new Station 41. He said the furniture, fixtures and equipment have been ordered, and some have not yet arrived.

He indicated that the carpeted flooring in the living area in Station 40 may have to be replaced to enable it to be sanitized.

He reported there are several trees on the back side of Station 44 that could potentially fall on the road or the station and may have to be trimmed or removed.

He discussed the new staff vehicles have been ordered and one has been received. They are currently rotating all of the apparatus to get their annual services.

He reported that the County has approved \$400,000 for a county-wide evacuation platform for the next three years, and we are included in that.

As to grants, he reported they made a purchase of wild land gear, and we have applied for a 2020 volunteer fire assistance grant.

He discussed budget and personnel issues and that interviews have been scheduled.

He reported that they will be submitting the District of Distinction application shortly.

There was some discussion between Deputy Chief Cox and the Board about who pays for the Battalion Chiefs.

Director MacKimmie asked Deputy Chief Cox if the Board could get a monthly report on staffing, and Deputy Chief Cox said he will look into that.

President Burke asked about one of the three engines being on the Coast and Deputy Chief Cox responded. President Burke asked this to be on the agenda for next month's meeting.

Director Stockman commented on the Board's inability to discuss certain things because of the Brown Act restrictions. He asked how we could have a time for open discussion.

Director Stockman discussed the triangular area at new Station 41.

Director Stockman said the California Fire District's annual conference is coming up in October, and he will send the agenda to Deputy Chief Cox in case any other Board member wants to see it.
